ELIGIBILITY

- Open to all artists in the area.

CALENDAR

- May 1, 2021 – 9AM to 11AM– Artwork must be dropped off at the SHS (each piece with a completed and signed Entry Form) and JPEG images to be provided.
- May 8 – In-Person and Online Exhibit opens. PLEASE NOTE: THERE WILL LIKELY BE NO IN-PERSON OPENING PARTY FOR THIS EXHIBITION THOUGH WE MAY HAVE AN IN-PERSON EVENT LATER IN THE RUN OF THE SHOW
- July 9, 2021 - Exhibit ends
- July 10 - Pickup unsold artwork 10AM to 11AM at the SHS.

GUIDELINES FOR ENTRY

1. Artwork may not have been previously exhibited at Gallery SHS and ideally will have been completed within the last year.
2. Entry forms are available on the SHS website (sharonhist.org > Museum > Exhibiting at the SHS > Entry Form) or in person at the SHS and must be completely filled out (all sections) and signed. A separate Entry Form is required for each piece of artwork submitted. Artist name and address may be “completed” by affixing printed address label with name and address.
3. All media are welcome. All two-dimensional work must be properly **framed, securely wired (no saw-tooth)** and ready to hang. Artists are reminded that our Gallery space is limited, so we may be unable to accept large art work.
4. Submitted works do not have to be for sale, however it is greatly preferred that they are. If the Artist submits more than one piece, at least one must be for sale.
5. The SHS will publicize the show with posters and press releases. Posters will be available for artists to distribute. Please provide jpegs of your entries prior to drop off if possible. Any works lacking jpegs will be photographed in their frames for the online exhibit by SHS.
6. Artists are requested to bring the “Artist’s Receipt” portion of their Entry Form(s) when picking up artwork. As a precaution, any Artist unable to pick up his or her artwork in person may be asked to submit a signed direction letter to the Sharon Historical Society & Museum authorizing release of artwork to another person and instructing SHS where to send any proceeds of sales of the Artist’s work. Any person so authorized, and any Artist not in possession of his or her Artist’s Receipt, may be asked to show a photo ID.
7.
